FIRST AID

MIXING

1. Fill spray tank 1/2 full of water and begin agitation.
2. Add recommended amount of FIRST CHOICE ULTRA PRO.
3. Add pesticides as directed by label or in the following sequence and continue filling tank.
 1. Dry flowables or water dispersible granules
 2. Wettable powders
 3. Flowables
 4. Solutions
 5. Emulsifiable concentrations
4. Continue agitation until spray solution is completely mixed.

RECOMMENDATIONS

Specific use rates will vary with conditions of application such as water hardness, application method, equipment, spray droplet size, condition of foliage, etc. Rates of FIRST CHOICE ULTRA PRO higher than those below may be used if recommended by pesticide labeling. Follow pesticide label directions. However, do not add this product at a rate which exceeds 5% of the finished spray volume.

Herbicides, Defoliants, Desiccants: 4-8 quarts per 100 gallons of finished spray volume.

For improved efficiency, use at least 1 pint of FIRST CHOICE ULTRA PRO per acre when finished spray volume is less than 20 gallons per acre. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.

GENERAL USE DIRECTIONS

FIRST CHOICE ULTRA PRO enhances the activity of ROUNDUP[®] and other products whose labels specify the addition of ammoniated salts/ammonium sulfate.

1 gallon of First Choice Ultra Pro contains 3.9 lbs. of ammonium sulfate.
