Mixing should take place just prior to application and at the quantity to be used. Combine ingredients at the concentrations specified below and SHAKE, STIR, OR AGITATE for five minutes before use. First Choice Ascend™ PA and First Choice Ascend™ NTC are ready for use after mixing and when the liquid has turned **green** in color. Do not use First Choice Ascend™ PA and First Choice Ascend™ NTC if liquid is not green in color.
