### GENERAL INFORMATION

**FIRST CHOICE ClearCal** is a liquid concentration containing calcium and polyacrylamides. **FIRST CHOICE ClearCal** increases soil stabilization and improves soil structure. **FIRST CHOICE ClearCal** is recommended to improve irrigation efficiency, and reduce sodium buildup in the soil. **FIRST CHOICE ClearCal** is recommended in crops where insufficient calcium levels are indicated by laboratory analysis. Rates may vary from 2½ -20 gallons per planted acre and may be repeated as necessary depending on desired results. **FIRST CHOICE ClearCal** may be applied as an undiluted spray followed by irrigation or injecting into the irrigation water. **FIRST CHOICE ClearCal** may be applied alone, with other fertilizers, or in tank mixes containing pesticides. **FIRST CHOICE ClearCal** IS NOT COMPATIBLE WITH FERTILIZERS CONTAINING PHOSPHATE OR SULFATES. When use of an unfamiliar mix is made a compatibility test is always recommended.

### DIRECTIONS FOR USE

Soil must be loose and friable prior to application of **FIRST CHOICE ClearCal**. If crust has formed due to irrigation or rainfall, **FIRST CHOICE ClearCal** will not re-establish soil structure.

#### Sprinkler:

Single Application: 15-20 gallons per acre  
Repeat Applications: 10 gallons per acre

#### Furrow:

Apply 5-15 gallons per acre as required.

#### Drip:

Apply 2.5 gallons per acre undiluted. Higher rates may be used by sufficiently diluting the solution.
